#### Glossary

NICE Interventional Procedures Guidance: covers procedures used for diagnosis or treatment, considers if

they are safe and work well enough for wider use in NHS England, Scotland or Wales

HTW Topic Exploration Report: designed to provide a high-level briefing on new topics submitted for

consideration in Wales.

**NICE Health Technology Evaluation:** rapid assessment of digital products, devices and diagnostics (also known as Early Value Assessment, or EVA). Provides guidance on value of a technology and recommendations for use whilst further evidence is generated.

**NICE Diagnostics Guidance**: evaluates new, innovative diagnostic technologies. It includes all types of measurements and tests that are used to evaluate a patient's condition.

Health Information and Quality Authority (HIQA) Advice: summarises clinical and cost-effectiveness evidence and implications for the health technology in Ireland

**HTW Guidance:** summarises clinical- and cost-effectiveness evidence and implications for the health technology in Wales

SHTG Assessment: bespoke reviews of health technologies to inform policy and practice across NHS Scotland
